

Chlordane is an effective insecticide that controls insects two ways: By contact or when eaten.

Apply 5% Chlordane Dust as it comes in the package through the sifter top or with a hand duster.

FOR LAWNS: To control Ants, Chinch Bugs, and Chiggers - Dust evenly at the rate of 1 pound on 400 to 500 sq. ft. of area. To control White Grub and Sod Webworm (Lawn Moth) - Apply liberally at the rate of 1 pound on 200 to 250 sq. ft. Following treatment for White Grub, water thoroughly with sprinkler. Note: Keep children and pets off treated lawn until this material has been washed into the soil by sprinkling or rain and treated lawn is completely dry.

IN ORNAMENTAL GARDENS: To control Cutworms, Earwigs, Mole Crickets, Sowbugs, Millipedes, Slugs, Snails, and Leaf Cutting Ants on Flowers, Shrubs and other Ornamentals - Dust evenly on the ground around the plants. One pound treats 200 to 250 sq. ft. Retreat as necessary. Do not use on food plants.

FOR FOLIAGE DUST: To control Grasshoppers, Thrips, and Plant Bugs on Flowers, Shrubs and other Ornamentals - Dust evenly on the plants and insects. Repeat treatments as needed to prevent damage.

FOR GARDEN SOIL: Use as a preplant soil application only. To control wireworms, white grub, root maggot on Radishes, Onions, and Cabbage -- Work into top 2 or 3 inches of soil when preparing seed beds. One pound treats 500 to 600 sq. ft.

IN THE HOME: To control Ants, Cockroaches, Water Bugs, Silverfish and Spiders - Apply in cracks, corners, behind shelving, bookcases and storage areas, openings around water pipes, electrical outlets and heat ducts and other areas where insects have been seen resting, running or hiding. Repeat applications as often as needed to maintain effective control.

TO CONTROL FLEAS: Dust sleeping quarters of pets outside the home. Repeat applications as necessary.
