INSTRUCTIONS FOR USE: One Model CB 5-24 "After Hours" automatic "once-a-day" timed dispensing unit should be installed for each 8,000 cubic feet of space to be treated. Set Dispenser timer for desired hour of activation. Insert Aerosol. Put switch in "ON" position. Dispensers should be located high, at least 7-8 feet from floor. Keep in mind that such factors as air flow rate, size of space treated, humidity and room temperature all affect insect activity and control. Large drafts of forced ventilation may reduce the insecticidal efficacy of these installations.

The CB 5-24 activates NEW PURGE 5-24 200 MG metered valve once each 15 minutes for one 5 hour period every 24 hours. After one hour of operation, enough NEW PURGE 5-24 is suspended in the air to kill a substantial proportion of flies, mosquitos and gnats present. As with any method of insect control, best results are achieved when basic sanitation, screening and other positive insect prevention practices are followed. The CB 5-24 is an automatic, unattended, effective "AFTER HOURS" augmentation of your insect control procedures. Exposed food should be covered prior to activation period of the dispenser.

This 24-oz. can of NEW PURGE 5-24 contains over 6,000 metered "shots." The CB 5-24 unit should be serviced and checked every 120 days. SEE FULL INSTRUCTIONS FOR USE AND SERVICE CONTAINED IN EACH CB 5-24 DISPENSER
