

## PRECAUTIONARY STATEMENTS

### CAUTION

#### Hazards to Humans & Domestic Animals

Harmful if swallowed or absorbed through the skin. Avoid breathing vapors. Avoid contact with skin. In case of contact, immediately flush skin with plenty of water. Do not use in commercial food processing or preparation areas. Do not spray in areas where food and feedstuff are exposed or handled.

#### STATEMENT OF PRACTICAL TREATMENT

If Swallowed: Do not induce vomiting. Call a physician or Poison Control Center immediately.

If Inhaled: Remove to fresh air.

If on Skin: Remove contaminated clothing and wash affected area with soap and water. Get medical attention if irritation persists.

If in Eyes: Flush eyes with plenty of water. Get medical attention if irritation persists.

Note to Physician: Contains petroleum distillate. Vomiting may cause aspiration pneumonia.

#### ENVIRONMENTAL HAZARD

This pesticide is highly toxic to fish. Do not apply directly to water or wetlands (swamps, marshes, bogs, potholes). Drift and runoff from treated sites may be hazardous to fish in adjacent waters.

#### PHYSICAL OR CHEMICAL HAZARDS

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130° F may cause bursting.

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Application should be made in the late evening when insects are at rest. Hold can upright. Remove cap. Point valve opening away from face.

Outdoors: (Wasps, Hornets, Yellowjackets). With wind at back, aim at nests in trees, bushes, under leaves and eaves, chimneys, cracks and crevices.

Indoors: (Bees). Bees are beneficial insects. Applications should be made only for bees that invade buildings. Aim directly at nest under rafters, in wall voids, attics and warehouses.

#### STORAGE & DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in a cool, dry area away from heat or open flame.

DISPOSAL: Do not reuse empty container. Replace cap, wrap empty container in newspaper and discard in trash. Do not puncture or incinerate.
