The re-submissions referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, to provide a revised label which changes the "First Aid" statements as required per PR Notice 2001-1, and which makes other changes required in the EPA letter dated 10/19/03, are acceptable providing you submit three copies of a final printed label which makes the following minor label changes.

- 1. Correct "with spray heat beneath actuator" to "with spray head beneath actuator".
- 2. Delete the claim "Authorized by USDA for use in federally Inspected Meat and Poultry Plants". The EPA does not allow claims of endorsement by other Federal agencies. This claim has been blacked-out on the attached stamped copy which supercedes all prior label versions.
- 3. In the "Directions For Use", delete the word "highly" (implies heightened efficacy) from "highly effective". This word has been blacked out on the attached label.

A copy of the label (version R3EPAA19), stamped "Accepted with comments" is attached. This label supercedes all prior accepted label versions. Please include a copy of this letter with your final printed labels.
