Use at least 1 container for each 9,000 cubic feet of unobstructed space. Use additional units for remote rooms where mist will not flow freely. Place can on table or stand. Place newspaper under container to prevent marring of surface. This product may affect some plastics. Cover or remove plastic items such as plastic furniture, stereo covers and components, motion boxes, eye glasses, etc.

Close doors and windows. Open cabinets and closets. Shut off fans and air conditioners. Put out all open flames except pilot lights. Place can at least 6 feet from pilot lights. Keep at arm's length when releasing. Point valve opening away from face and eyes. Press tab of actuator down until it locks. Leave the building at once. Leave undisturbed for at least 30 minutes. Ventilate area before re-entering. Repeat treatment as necessary.

STORAGE & DISPOSAL

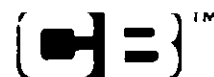
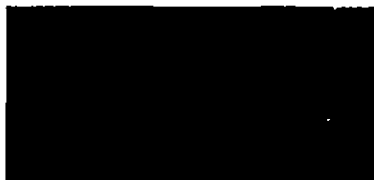
