

**DIRECTIONS FOR USE:**

**Indoors** — Flying Insects: Flies, Mosquitoes, Moths, Gnats. Vacate premises for at least 15 minutes after spraying and aerate before re-entering. Cover fish bowls and remove bird cages and all pets. Foods should be removed and covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using the product in these areas, apply only when facility is not in operation. Spray in a sweeping motion for 2-3 seconds for average size room.

**Crawling Insects:** Roaches, Water Bugs, Spiders, Silverfish. Spray directly on insects or in cracks and crevices, storage and refuse areas. For Ants, spray ant trails, nests and points of entry.

**Outdoors** — Kills sucking insects: Aphids, Mites, Lace Bugs, Leaf Hoppers.

**Kills chewing insects:** Japanese Beetles, Mexican Bean Beetles, Army Worms.

Spray garden plants only when there is no wind. Spray lightly with sweeping motion 2 feet away from foliage and blossoms. Spray can be used on Roses, Dahlias, Chrysanthemums, Geraniums, Asters, Evergreens and other ornamentals.
