

PRECAUTIONARY STATEMENTS

CAUTION:

Hazards to Humans & Domestic Animals: Harmful if swallowed or absorbed through the skin. Avoid breathing vapors. Avoid contact with skin. Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment and thoroughly cleaned before using. When using the product in these areas, apply only when facility is not in operation. Remove pets, birds, and cover fish aquariums before spraying. Avoid contact with skin and eyes.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Indoors: Flying Insects (Flies, Mosquitos, Small Flying Moths, Gnats). Vacate premises for at least 15 minutes after spraying and aerate before re-entering. Spray in sweeping motion for 2-3 seconds for average size room.
Crawling Insects: (Roaches, Water Bugs, Spiders, Silverfish). Spray directly on insects or in cracks and crevices, storage and refuse areas. For Ants, spray ant trails, nests and points of entry.

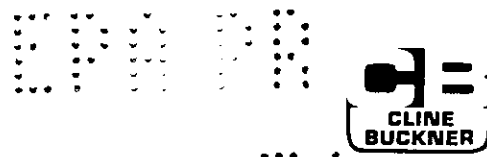
Outdoors: (Kills Sucking Insects: Aphids, Mitos, Lace Bugs, Leaf Hoppers).

(Kills Chewing Insects: Japanese Beetles, Mexican Bean Beetles, Army Worms). Spray garden plants only when there is no wind. Spray lightly with sweeping motion 2 feet away from foliage and blossoms. Spray can be used on Roses, Dahlias, Chrysanthemums, Geraniums, Asters, Evergreens, and other ornamentals.

Disposal: Do not reuse empty container. Wrap container and put in trash collection.
