Dear Ms. Rohner:

The proposed amendment to the registration for the product cited above under The Federal Insecticide, Fungicide And Rodenticide Act as amended revising the label by adding a claim for effectiveness against mosquitoes which may carry West Nile Virus is acceptable subject to the comments listed below:

The referenced studies are sufficient for the preliminary acceptance of the requested label claim for mosquitoes including those that may transmit WNV. The following label language is acceptable:

“ Kills and repels Flies, Mosquitoes [including Culex species] which/that may carry/transmit the West Nile Virus], Gnats and Small Flying Moths.”

However, due to the unacceptable control mortalities observed in the latter study, confirmatory data are necessary. Corroborative data must be submitted or cited within 12 months of the date of this letter.

In addition the label claim, “Lasts 30 Days”, must be deleted and replaced with, “Container lasts for up to 3 applications. Approximately 2.12 oz. (60g) is dispensed at each metered interval.”. This determination is based upon information provided by you. Refer to the enclosed Efficacy review for details.

The label must also be revised as follows:

Delete the statement, “Authorized by USDA for Use in Federally Inspected Meat and Poultry Plants.”. USDA no longer reviews labeling or authorizes products for use in these plants.



CAUTION

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

FOR USE IN Food service and preparation areas, food processing plants, restaurants, clubs, stores, supermarkets, bottling plants, warehouses, buildings, factories, offices, laboratories, lavatories, ships, planes (cargo areas), hotels, motels, hospitals, nursing homes, schools, day-care centers, funeral homes, kennels, farms, barns, stables, dairies, homes, milk and egg handling areas of dairies and chicken houses.

This product is engineered for use in automatic metered dispensers. The dispenser automatically activates the special metered valve every 15 and/or 30 and/or 45 minutes. Within 24 hours the area is relatively free of flies, mosquitoes, gnats, and small flying moths and with continued use reduces annoyance from them. Effectiveness of this product will be noticeable within one hour after the Dispenser is activated. Recommended use is for 24 hours: but if less than 24 hour use is required, the Dispenser should be set to start one hour before control is desired and run one hour after control is no longer needed. Factors such as airflow rate, size of space treated, humidity and room temperature affect insect activity and control. Therefore, one unit per 6,000 cubic feet of unobstructed space should be considered as an average with adjustments made depending on specific conditions at usage site. As with any method of insect control, best results are achieved when sanitation and other positive insect prevention practices are followed.

Do not use in aircraft cabins. It is suggested that the container be changed once a month.

OPERATION: Remove protective cap from top of can and insert can in dispenser. Suspend dispenser 7 feet from the floor and at a point where wind flow will carry the particles throughout the room.

OUTDOORS: This product can be used to treat dog kennels, dog runs, side yards, patios, decks & [and] residential landscapes. Set the dispenser to treat at dawn & [and] dusk & [and] use when humans are not in the area. When heavy pest infestations are present the dispenser may be set to treat at [15], [30], [45] [15 – 45] minute intervals. Place the dispensers out of the reach of pets & [and] children & [and] use the prevailing wind to assist in carrying the spray throughout the area to be treated. This product can be used to control [aid in controlling] Flies, Mosquitoes, [including the Culex species] [which may carry] [that may carry] [that carry] [which carry] [and transmit] [the West Nile Virus] [including those that [carry] West Nile Virus], gnats & [and] small flying moths. Each dispenser will treat up to 650 square feet. Use enough dispensers to treat the entire area you want protected.
