The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable, subject to the comments listed below:

1. Make the following changes on page one of your product label to read:

a. Kills Mosquitoes, [including Culex species] [which may carry] [the West Nile Virus].

b. On page two under the sub-head "OUTDOORS", revise the following to read:

This product can be used to Kill mosquitoes, [including Culex species which may Carry] [the West Nile Virus]. Each dispenser will treat up to 650 square feet. Use enough dispensers to treat the entire area you wanted protected.

2. The proposed additional brand names:

Pyrethrin Powered, Protection Plus, Synergized Pyrethrin, MAX-KIL Formula, Xtreme-KIL Formula, and Extreme Performance are unacceptable. It is the Agency view that these unqualified terms, are misleading health and safety claims and therefore constitute misbranding under section 2 (q) (1) (A) of FIFRA. For additional guidance you may refer to the label review manual, (copy attached), page 7.

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**FOR USE IN** Food service and preparation areas, food processing plants, restaurants, clubs, stores, supermarkets, bottling plants, warehouses, buildings, factories, offices, laboratories, lavatories, ships, planes (cargo areas), hotels, motels, hospitals, nursing homes, schools, day-care centers, funeral homes, kennels, farms, barns, stables, dairies, homes, milk and egg handling areas of dairies and chicken houses.

This product is engineered for use in automatic metered dispensers. The dispenser automatically activates the special metered valve every 15 and/or 30 and/or 45 minutes. Within 24 hours the area is relatively free of flies, mosquitoes, gnats, and small flying moths and with continued use reduces annoyance from them. Effectiveness of this product will be noticeable within one hour after the Dispenser is activated. Recommended use is for 24 hours: but if less than 24 hour use is required, the Dispenser should be set to start one hour before control is desired and run one hour after control is no longer needed. Factors such as airflow rate, size of space treated, humidity and room temperature affect insect activity and control. Therefore, one unit per 6,000 cubic feet of unobstructed space should be considered as an average with adjustments made depending on specific conditions at usage site. As with any method of insect control, best results are achieved when sanitation and other positive insect prevention practices are followed.

Do not use in aircraft cabins. It is suggested that the container be changed once a month.

**OPERATION:** Remove protective cap from top of can and insert can in dispenser. Suspend dispenser 7 feet from the floor and at a point where wind flow will carry the particles throughout the room.

**OUTDOORS:** This product can be used to treat dog kennels, dog runs, side yards, patios, decks & [and] residential landscapes. Set the dispenser to treat at dawn & [and] dusk & [and] use when humans are not in the area. When heavy pest infestations are present the dispenser may be set to treat at [15], [30], [45] [15 - 45] minute intervals. Place the dispensers out of the reach of pets & [and] children & [and] use the prevailing wind to assist in carrying the spray throughout the area to be treated.
