TimeMist Insecticide II is engineered for use in the TimeMist Automatic Aerosol Dispenser. The TimeMist Dispenser automatically actuates the special metered valve every fifteen minutes. Within 24 hours the area is relatively free of the specified small flying insects and with continued use reduces annoyance from them. One TimeMist Dispenser is designed to protect a room up to 30'x 20'x 10' for 30 days, 24 hours a day. TimeMist Insecticide II contains 3000 sprays when dispensed at a rate of 60 mg. per spray.

**OPERATION:** Remove protective cap from top of can and insert can in TimeMist Dispenser. Suspend Dispenser 7 feet from the floor and at a point where wind flow will carry the particles throughout the room.

**STORAGE & DISPOSAL**

Do not contaminate water, food or feed by storage or disposal.

**STORAGE:** Store in a cool, dry area away from heat or open flame.

**DISPOSAL:** Do not reuse empty container. Replace cap, wrap empty container in newspaper and discard in trash. Do not puncture or incinerate.
