Q-MIST BUG KILLER is an effective formulation designed for use in automatic aerosol dispensers.

Used in the Q-Mist Automatic Dispenser the special valve is actuated automatically, emitting 100 mg. doses each 15 minutes. Each dose contains millions of tiny particles which float in the air, killing a high proportion of flies, mosquitoes, gnats, moths and certain other small flying insects.

Usually, the effectiveness of Q-Mist Bug Killer will be noticeable within one hour after the dispenser is actuated. If less than 24 hour control is required, the dispenser should be set to start one hour before control is desired and one hour after control is established.

Factors such as air change rate, size and shape of space treated, humidity and temperature affect the insect activity and control. One dispenser per 6,000 cubic feet may be considered an average, although in a wind-free area more coverage can be expected. Best results are achieved when good sanitary practices are used. For best results, mount the dispenser as high as possible and in a location where moving air will carry spray throughout the desired area.

- Pyrethrin 0.45%
- Piperonyl butoxide Technical* 0.90%
- N-octyl bicycloheptene dicarboximide 1.50%

INERT INGREDIENTS 97.15%

* Consists of 0.72% (butylcarbityl) (6-propylpiperonyl) ether and 0.18% of related compounds.
