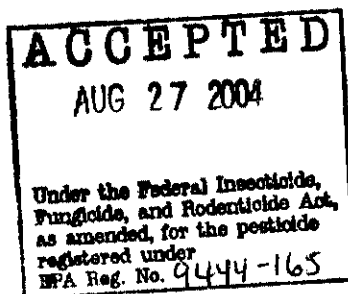

HAZARDS TO HUMANS & DOMESTIC ANIMALS
CAUTION**

Harmful if swallowed or absorbed through skin. Contains petroleum distillates. Do not breathe vapors or spray mist. Avoid contact with skin or eyes. Wash with soap and warm water after use. Avoid contamination of food or feedstuffs.

FIRST AID

If on Skin or Clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

If in Eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

It reaches fleas hidden in carpets, rugs, drapes, upholstery, pet bedding, and floor cracks. Protects your home from reinfestation and flea buildup and your pets and family from bites. One treatment with this spray gives continuous flea protection for 120 days. Leaves no objectional odor or sticky mess and used as directed does not stain furnishings.

FLEAS AND TICKS: Hold can 2 or 3 feet from surfaces to be treated. Be sure to apply uniformly using a sweeping motion to carpets, rugs, drapes and all surfaces of upholstered furniture.
