

**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS & DOMESTIC ANIMALS
CAUTION**

Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing spray mist or contact with skin. Wash thoroughly after using. Avoid storage near food or feed. Do not spray on pets, humans or other animals.

Do not use in edible product areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

STATEMENT OF PRACTICAL TREATMENT

If Swallowed—Call a physician or Poison Control Center. Do not induce vomiting because of possible aspiration hazard.

If on Skin—Wash thoroughly with soap and water.

If in Eyes—Flush with plenty of water. Get medical attention if irritation persists.

PHYSICAL OR CHEMICAL HAZARDS

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting. Do not spray on plastic, painted or varnished surfaces or directly into electronic equipment such as radios, TVs, computers, etc. To reduce possible staining on painted or vinyl surfaces or roof shingles, rinse with clear water within 10 to 15 minutes after application.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

To operate, remove protective cap and depress button, being sure to aim spray opening at the location to be sprayed. Direct spray at insects wherever possible and under eaves, into nests, cracks, holes or crevices wherever insects are not dead. Spray for about 10 seconds or until surface is moist from insecticide. To prevent entrance of insects into the house, spray around points where outside plumbing and faucets enter the house and into any cracks or crevices in foundations as well as along sills and ledges.

Kills Wasps, Hornets and Yellowjackets: This spray is fast acting when insects are hit directly. Allow about 24 hours for those insects which were not directly hit by spray to leave the area. If insects should return to the treated area, spray again. This container delivers a stream-type spray, making it possible for the operator to stay back from the places sprayed.

Bee (Honey): Bees are beneficial insects. Application should be made only for bees that invade buildings. Aim directly at nests under rafters, in wall voids, attics and warehouses.

This formulation utilizes pyrethrins, piperonyl butoxide and a carbamate-type insecticide, a combination particularly effective on this class of insects.

STORAGE & DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

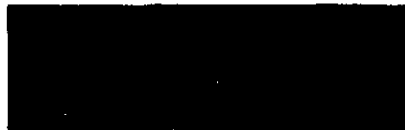
STORAGE: Store in a cool, dry place away from heat or open flame.
