

Cockroaches, Waterbugs, Silverfish, Crickets, Spiders, Centipedes, and Sowbugs: General Volumetric Treatment- Open cabinets and doors in area to be treated. Bedbugs: Spray mattresses, particularly around tufts and seams. Take beds apart and spray into all joints. Treat baseboards, molding and floors. Repeat as necessary.
