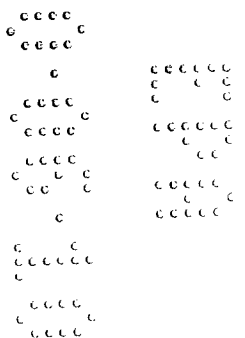

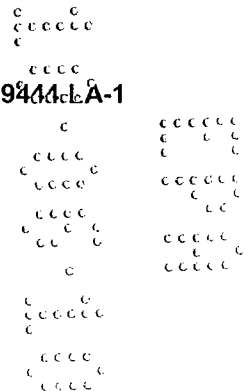

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

FOR USE IN [ON] Food handling and food preparation areas of restaurants and food processing plants, stores, farms, dairies, barns, kennels, factories, hotels, motels, offices, ships, planes (cargo area only), supermarkets food warehouses, bottling plants, [porch] [&] [patio], homes, milk and egg handling areas of dairies and chicken houses.

This product contains a highly effective insecticide designed especially **FOR USE IN** automatic dispensers. The dispenser activates the metered valve every 15 minutes. Usually the effectiveness of this product will be noticeable within one hour after the Dispenser is activated. If less than 24 hour control is required, the Dispenser should [be set to] start one hour before control is desired and run one hour after control is no longer needed. Keep in mind that factors such as airflow rate, size of space treated, humidity and room temperature affect insect activity and control. Therefore, one unit per 6,000 cubic feet of unobstructed space should be considered as an average with adjustments made depending on specific conditions at usage site. As with any method of insect kill, best results are achieved when sanitation and other positive insect prevention practices are followed.

Do not use in aircraft cabins. It is suggested that the container be changed once a month.

OUTDOORS: This product can be used to treat dog kennels, dog runs, side yards, patios, decks & [and] residential landscapes. Set the dispenser to treat at dawn & [and] dusk & [and] use when humans are not in the area. When heavy pest infestations are present the dispenser may be set to treat at [15], [30], [45] [15 - 45] minute intervals. Place the dispensers out of the reach of pets & [and] children & [and] use the prevailing wind to assist in carrying the spray throughout the area to be treated. This product can be used to kill gnats & [and] small flying moths. Each dispenser will treat up to 650 square feet. Use enough dispensers to treat the entire area you want protected.

OPERATION: Remove protective cap from top of can & [and] insert can in dispenser. Secure dispenser at least 7 feet from floor or ground & [and] at a point where air flow or wind will carry the particles throughout the area to be protected.

GENERAL PRECAUTIONS & USE RESTRICTIONS

- Apply this product only as specified on this label.
- Do not contaminate food or feedstuffs.
- Do not enter or allow others to enter until vapors, mists and aerosols have dispersed, and the area has been thoroughly ventilated.
- Do not apply this product in a way that will contact workers or other persons, either directly or through drift.
