


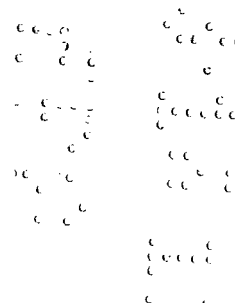
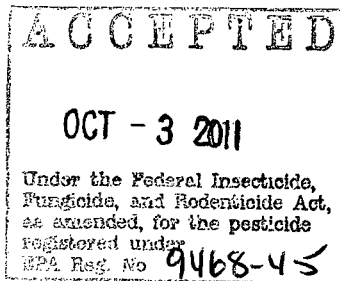

Asparagus, corn, fallow systems, grass forage, fodder and hay (including grasses grown for seed), millet, small grains (barley, oats, wheat), sorghum (including sudangrass), soybeans, sugarcane, cotton, pasture and rangeland, Conservation Reserve Program Areas, farmsteads, fence rows, lawns, non-irrigation ditchbanks, rights-of-way, roadsides, turf and sod farms;
2. Uses for which EPA has accepted the required data and/or citations of data that the formulator has submitted in support of registration.
3. Uses for experimental purposes that are in compliance with EPA registration for the formulated products.

This product may be used to formulate products for specific uses not listed on the label if the formulator, user group, or grower has complied with U.S. EPA data submission requirements regarding support of such uses.

Each formulator is responsible for obtaining EPA registration for their end-use product(s).

**STORAGE AND DISPOSAL**
