DIRECTIONS

Remove children, pets or fishbowls from the quarters, cover foods and any utensils that may be used for foods. Use only a coarse spray in the cracks, crevices and other hiding places of roaches and other insects, applying enough to wet the surface without any run-off of the spray. The insects that are hit by the spray are killed, and others are killed when they rest on the residual deposits. Repeat after 2 to 4 weeks, or as needed.
