DO NOT APPLY IMMEDIATELY PRIOR TO OR DURING TEMPERATURES IN EXCESS OF 75°F. Treatment during cool early evening or mid-morning is best.

Dichondra lawns should not be treatimmediately after mowing. Wait until the dichondra has had time to produce some new growth.

Add 4oz. "SPURGE-X" to one gallon of water. This will treat about 100 sq.ft.(10'X10',5'X20",etc.)Aprlication should be by a PRESSURE- TYPE sprayer (Hudson). Hose proportioners or water cans are not very effective and should NOT be used.

Saturate spurge foliage but if possible, avoid excessive contact with ichondra. You may get some damage to the dichondra (tip burn) but it will soon completely recover.

"SPURGE-X" will not interfere with the germination of seeds.

Clean sprayer thoroughly immediately before and after use. Be sure to flush sprayer system with clear water under pressure.
