## DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

To operate hold can upright, direct orifictoward the surfact to be treated, and press the actuator button. Do not use as a space spray.

To Kill ants, carpet beetles, centipedes, cockroaches, crickets, earwigs, firebrats, pillbugs, silverfish and spiders; thoroughly apply as a spot treatment to areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices, under carpets, along baseboards and door sills and frames; behind and beneath sinks, stoves, refrigerators, and cabinets around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests and points of entry.

To Kill fleas and brown dog ticks; apply thoroughly as a spot treatment to infested areas such as pet beds and resting quarters. and nearby cracks and crevices; along and behind baseboar Sindow and door frames and localized areas of floor and floor covering where these pests may be present. Fresh bedding should be placed in animal quarters following treatment. Do not spray pets with this product. Treat your pets with a product registered for application to animals to control the source of your flea infestation.

To Control flies, gnats, hornets, mosquitoes, small flying moths, wasps and yellow jackets; use only on outdoor surfaces. Spray outside surfaces of window and door frames and other areas where these pests may enter the home. Also spray dark corners and localized resting areas, such as under eaves, porches, partitions and in garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes. APPLICATION OF THIS PRODUCT IN THE FOOD AREAS OF FOOD HANDLING

ESTABLISHMENTS OTHER THAN AS A SPOT AND/OR CRACK AND CREVICE TREATMENT IS NOT PERMITTED.

Application within Food Handling Establishments (places other than private residences in which exposed food is held, processed, prepared or served) including, but not limited to, areas for receiving, storage, packing (canning, bottling, wrapping, boxing), preparing foods, edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups) and serving areas (when food is exposed and facility is in operation); Use as a crack and crevice treatment in and around both food and nonfood areas to control ants, cockroaches, crickets, silverfish, spiders, and waterbugs, Apply in small amounts directly into cracks and crevices, in points between different elements of construction, between equipment and floor, openings leading to

voids and hollow spaces in walls, equipment legs and bases, in conduits, motor housings, Junction or switch boxes. Prior to application de-energize electrical equipment. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food and food processing surfaces.

Application within Food Serving Areas (facilities where foods are served, such as dining rooms, but excluding areas where foods may be prepared or held); Apply as a spot treatment to selective surfaces, such as baseboards, under elements of construction and into cracks and crevices. Avoid treating surfaces likely to be contacted by food. (Do not apply when facility is in operation or foods are exposed)

Wrap container and dispose of in trash. Do not incinerate. PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

May be harmful if swallowed, inhaled or absorbed through skin. Avoid breathing spray mist. Avoid contact with skin, eyes and clothing. Do not allow children or pets to contact treated surfaces until spray has dried. Do not spray air in rooms or use on plants. Apply as a surface spray only, Do not allow spray to contact food, feedstuffs or water supplies. in the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Remove pets and cover fish bowls before spraying. Not to Physician: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically, Atropine by injection is antidotal only if symptoms of cholinesterase inhibition appear.

STATEMENT OF PRACTICAL TREATMENT If on Skin: In case of contact, remove contaminated cluthing and immediately wash skin with soap and water. If in Eyes: Flush eyes with plenty of water, Call a physician. if Inhaled: Remove victim to fresh air, Apply respiration if indicated.
