

PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS & DOMESTIC ANIMALS

CAUTION

Harmful if swallowed: Inhaled or absorbed through the skin. Avoid breathing of spray mist and provide adequate ventilation of area being treated. PHYSICAL OR CHEMICAL HAZARDS

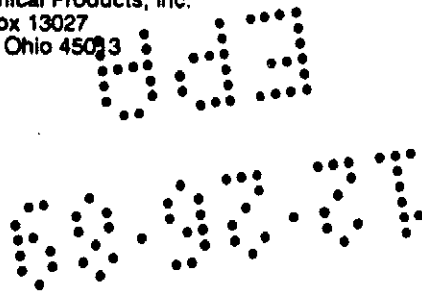
STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: Do not induce vomiting. Seek medical attention immediately.

To Operate: Hold container upright: nozzle away from you and spray infested surfaces only until wet.

ROACHES, ANTS, WATERBUGS, SILVERFISH, SPIDERS, CRICKETS: Spray into all cracks, around baseboards and other places where these insects hide. Also spray until wet, surfaces behind and beneath cabinets, refrigerators, sinks and stoves. Spray other localized areas infested with these pests. Repeat treatment as required. Do not spray foodstuffs or house plants. Do not allow children to contact treated surfaces until surfaces are completely dry.

BROWN DOG TICKS: Thoroughly spray infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of household pets and localized areas of floors and floor coverings. Applications should be repeated as infestations warrant and as reinfestation occurs. Fresh bedding should be placed in animal quarters following treatment. Do not treat animals with this formulation.

FLIES, MOSQUITOES and FLYING MOTHS Outdoors: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages and other places where these insects alight or congregate. Repeat treatment as necessary.

FLEAS, ANTS, BROWN DOG TICKS, CLOVER MITES, EARWIGS, CRICKETS, MILLIPEDES Outdoors: For treatment of localized infestations of these insects in outdoor areas or where these insects may enter the dwelling, spray infested areas thoroughly. For Ants, thoroughly wet hills and runways. For Fleas and Brown Dog Ticks, spray weeds and bushy non-crop vegetation. Repeat treatment as necessary. Do not spray desirable vegetation.

WASPS & HORNETS Outdoors: Apply after dark when all the insects have returned to the nest. Aim valve opening at nest. Hold at arms length and depress button, soaking the entire nest with spray. Repeat as necessary.
