DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling PA Rog. Directions: Shake well before using. Punch plastic seal. For use on carpets*, hold upside down across surface. Brush lightly with a broom to allow powder to penetrate carpet fibers. Wait 60 minute vacuum cleaner bag.) For severe problems or where ticks are known to be hiding, wait 2-3 hours be adheres to a spot, brush it out and vacuum immediately. Apply to dry surfaces only. Do not allow p use on upholstery*, remove all loose cushions. Sprinkle along creases, in corners. Brush gently, Sprinkle along underside of furniture. Do not use on exposed fabric; may cause staining. Remove I Wrap securely in several layers of newspaper and discard in trash.

To prevent a second generation from flea eggs in the carpet, repeat treatment in 7 days.

*Test on hidden surface of carpet or upholstery before using. If texture or color is effected, do not use Flea Killer For Carpets.

FLEA CONTROL FOR CATS & DOGS

Punch plastic seal. Hold can upside down and sprinkle powder over animal's back; head to tail, arounderbelly, the legs, the base of the tail and where fleas are seen; keeping out of pet's eyes and fact the hair until powder penetrates to skin. Repeat once weekly if necessary.

In addition to fleas; ticks and lice will also be killed when contacted by the powder. Do not treat pupple old. Treat pet sleeping quarters and replace with freshly laundered bedding. For continued control aduring the season.

FOR PET LIVING QUARTERS

Flea Killer for Carpets kills fleas, ticks and lice on contact. It is non-residual and is designed for use may be objectionable. Treat pet bedding and sleeping quarters liberally using 15 to 20 "sprinkles" (a) a 50 sq.ft. area. Treat pets resting areas such as infested basements, garages, and beneath porch per 250 sq.ft. Allow dust to remain for 3 to 4 hours and then, where necessary, sweep-up and discard a and Disposal.

To prevent a second generation from flea eggs repeat treatment in 5 to 7 days or as needed.

NOTE: Apply to your pet while out-of-doors or in a well ventilated area to avoid breathing airborne out-of-doors plan on repeat treatments at 2 to 3 week intervals during the season. Pets may be bail hours after treatment to remove dead fleas, ticks and lice.
