**PRECAUTIONARY STATEMENT:  
HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

**WARNING:** Causes eye damage and skin irritation. Do not get in eyes, on skin, or on clothing. Wear goggles, face shield and rubber gloves when handling. Harmful or fatal if swallowed. Avoid contamination of food.  
**FIRST AID:** In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes call a physician. Remove and wash contaminated clothing before reuse. If swallowed, give patient doses of powdered charcoal immediately or all he can swallow of raw egg white, milk, gruel, or flour and water. Then induce vomiting with salt, soap, or mustard in warm water. Call a physician immediately.  
**ENVIRONMENTAL HAZARDS:** This pesticide is toxic to fish. Do not discharge into lakes, streams, ponds, or public waters unless in accordance with an NPDES permit. For guidance contact your Regional Office of the EPA.

This product contains 1.67 lb. of active ingredients per gallon and weighs 9.25 lb. per gallon.

**STORAGE AND DISPOSAL**

**PROHIBITIONS:** Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.  
**PESTICIDE DISPOSAL:** Pesticide spray mixture, or rinse that cannot be used or chemically reprocessed should be disposed of in a landfill approved for pesticides or buried in a safe place away from water supplies.  
**CONTAINER DISPOSAL:** Containers under 30-gallon capacity must not be reused but should be triple rinsed and disposed of in an incinerator or landfill approved for pesticide containers or buried in a safe place. Containers over 30-gallon capacity should be resealed and offered for reconditioning or triple rinsed (or equivalent) and offered for recycling, reconditioning, or disposal in an approved landfill or buried in a safe place.

**DIRECTIONS FOR USE  
GENERAL CLASSIFICATION**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

ICC W54 is used to control algae, bacteria, and fungi in recirculating commercial and industrial water cooling towers. Prior to its use, systems must be cleaned to remove algal growth, microbiological slime, and other deposits. An initial slug addition of 3.3 to 6.6 fluid ounces of ICC W54 per 1000 gallons of water is recommended. Repeat initial dosage until control is evident.

Subsequent slug additions of 1.1 to 6.6 fluid ounces of ICC W54 per 1000 gallons of water should be employed every 1 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the microbiological problem. Slug additions should be made in the sump of water cooling towers.

**STATEMENT OF PRACTICAL TREATMENT**

**IF SWALLOWED:** Give patient doses of powdered charcoal immediately or all he can swallow of raw egg white, milk, gruel, or flour and water. Then induce vomiting with salt, soap, or mustard in warm water.

**IF ON SKIN:** Immediately flush skin with plenty of water for at least 15 minutes. Remove and wash contaminated clothing before reuse.

**IF IN EYES:** Immediately flush eyes with plenty of water for at least 15 minutes. Contact a physician.
