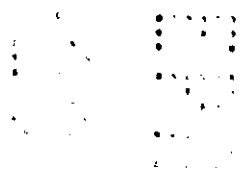

INITIAL APPLICATION: To a cleaned pool add one gallon to 50,000 gallons of water, or ratio thereof.

MAINTENANCE DOSE: Use one quart per 50,000 gallons of water every 5 to 7 days. When weather is hot or bathing load is heavy, use this dosage every 5 days or as necessary.

BOOSTER DOSE: Immediately after every rain add one quart per 50,000 gallons of water as above.

IMPORTANT: Follow above directions without fail, even when pool is not used. Algae growth must be fought at all times.

POOL-SIDE SURFACES: To scrub pool-side surfaces, use one oz. to four gallons of water for sanitizing or one oz. to two gallons of water for disinfecting.
