

BL FORMULA S-3 is an industrial cleaner which disinfects as it cleans. It is especially designed for schools, non-medical institutions and industry. A single application removes dirt and grime, disinfects, is virucidal, fungicidal, and will prevent the growth of mold and mildew and their odors. When used as directed, the hard surface disinfecting action of BL FORMULA S-3 will reduce the hazard of cross-contamination. BL FORMULA S-3 is also an extremely effective one-step sanitizer for non-food contact surfaces.

When used as directed, BL FORMULA S-3 will deodorize surfaces in toilet areas, behind and under sinks and counters, garbage cans and garbage storage areas, and other places where bacterial growth can cause mal odors.

Precautionary Statements

Hazard to Humans and Domestic Animals

DANGER

STATEMENT OF PRACTICAL TREATMENT

DIRECTIONS FOR USE

GENERAL CLASSIFICATION

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

BL FORMULA S-3 is a proven "one-step" cleaner - disinfectant - sanitizer - fungicide-mildewstat - virucide in the presence of moderate amounts of organic soil

Apply BL FORMULA S-3 to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks and bathtubs with a cloth, mop or mechanical spray device so as to thoroughly wet surfaces. All surfaces have to be cleaned. Prepare a fresh solution daily c. when use solution becomes visibly dirty.

Disinfection - to disinfect hard, non-porous surfaces, add 2 oz. per gallon of water. Treated surfaces must remain wet for 10 minutes.

The activity of BL FORMULA S-3 has been evaluated in the presence of 5% serum by the AOC use dilution test and found to be effective against a broad spectrum of gram negative and gram positive organisms as presented by:

Fungicidal Performance

BL FORMULA S-3 is effective against Trichophyton mentagrophytes (the athlete's foot fungus) when used on surfaces in areas such as locker rooms, shower and bath areas, exercise areas, dressing rooms, etc., at 2 oz./gallon.

Mold and Mildew Control

At 2 oz./gallon, BL FORMULA S-3 will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard, non-porous surfaces (as indicated in general instructions above). Allow to dry on surface and repeat when mold/growth returns.

Virucidal Performance
*At 2 oz. per gallon use-level, BL FORMULA S-3 was evaluated in the presence of 5% serum and found to be effective against the following viruses: Influenza A/Brazil, Herpes Simplex and Vaccinia, on inanimate environmental surfaces.

Sanitizing Non-Food Contact Surfaces (such as floors, walls, tables, etc.). At 5 oz. per 1/5 gallon use-level, 30 second contact time.
