STATEMENT OF PRACTICAL TREATMENT



DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Myco Sanitizer 64 is a concentrate and should be diluted before using.

FOOD PROCESSING AREAS: For sanitization of previously cleaned food processing equipment, food utensils, floors, walls and surfaces which come in contact with food, dilute 2 ounces of *Myco Sanitizer 64* per one (1) gallon of water to provide 200 ppm of active quaternaries. At this level, no potable water rinse is required.

HOUSEKEEPING: For sanitizing and disinfecting floors, walls, and inanimate surfaces. For School Locker Rooms, Garbage Pails, Sink Tops, Corridors, Classrooms, Offices and Shower Stalls.
