

**PRECAUTIONARY STATEMENTS**

**CAUTION**

**Hazards to Humans and Domestic Animals**

Harmful if swallowed or absorbed through skin. Avoid breathing vapor and spray mist. Avoid contact with skin and eyes. Remove pets, birds and cover fish aquariums before spraying. Do not apply directly to or around food. Cover or remove any food utensils and food processing equipment during application. Do not apply while food processing is underway. **Statement of Practical Treatment**

If Swallowed: Call a physician or Poison Control Center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear. Never induce vomiting or give anything by mouth to an unconscious person. If on Skin: Wash contaminated clothing and wash affected areas with plenty of soap and water. If in Eyes: Flush eyes with plenty of water. Call a physician if irritation persists. If Inhaled: Remove victim to fresh air. Apply artificial respiration if indicated.

One Dual Flea Control unit will kill fleas and other related insects in an unobstructed area up to 3,000 cubic feet (a 20' x 15' room with a 10' ceiling). Use additional units for remote rooms or where free flow of mist is not assured. Do not remain in the area during treatment and ventilate thoroughly before re-entry. Cover exposed food, dishes and food handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Remove overcap from Dual Flea Control and take sprayhead off of can, exposing stem. **SHAKE CAN WELL**. Turn overcap upside down and place over spray button locking it down, making sure can is pointed away from face. Place can in center of room on stand or table that has been thoroughly covered with several layers of newspapers or protective padding. Leave area at once and keep building closed for four hours before airing out. Open all doors and allow to air for 30 minutes. Repeat in two weeks or when necessary.

This product is also effective on Flies, Mosquitoes, Black Carpet Beetles, Sawtoothed Grain Beetles, Rice Weevils, Small Flying Moths, Spiders, Centipedes, Ticks, Wasps, Pillbugs, Crickets and Silverfish. Aids in control of Cockroaches.
