PRECAUTIONARY STATEMENTS

CAUTION

Hazards to Humans and Domestic Animals
Harmful if inhaled or absorbed through skin. Avoid breathing vapor and spray mist. Avoid contact with skin and eyes. Remove pets, birds and cover fish aquariums before spraying. Do not apply directly to or around food. Cover or remove any food utensils and food processing equipment during application. Do not apply while food processing is underway. After space spraying in areas where food is handled, wash all equipment, benches, shelving, etc. where exposed food will be handled with potable water.

Statement of Practical Treatment

If on Skin: Wash contaminated clothing and wash affected areas with plenty of soap and water. If in Eyes: Flush eyes with plenty of water. Call a physician if irritation persists. If Inhaled: Remove victim to fresh air. Apply artificial respiration if indicated. Never induce vomiting or give anything by mouth to an unconscious person. NOTE TO PHYSICIAN: This product may cause cholinesterase inhibition. Atropine is antidotal. 2-PAM may be effective as an adjunct to atropine.

Environmental Hazards

This pesticide is highly toxic to fish, birds and other wildlife. Do not apply directly to water or wetlands (swamps, bogs, marshes and potholes). Drift and runoff from treated sites may be hazardous to fish in adjacent waters.

Physical and Chemical Hazards

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Chemsico Ant and Roach Killer IV is a highly effective formulation which provides rapid kill of such crawling insects as listed below, including those resistant to certain other insecticides. In addition to rapid initial kill, Chemsico Ant and Roach Killer IV stays on treated surfaces and provides residual insect killing power for four to six weeks after spray deposit has dried.

HOW TO USE: Spray infested surfaces until wet, moving the spray stream rapidly to prevent excessive wetting of surfaces and waste of material. Point spray away from people, plants and pets. Do not introduce the spray into air or allow the spray to contact food or food contacting surfaces. Thoroughly wash dishes and food handling utensils with soap and water if they become contaminated by application of this product. Do not allow children or pets to contact treated surfaces until spray has dried. Remove pets and cover fish bowls (tanks) before spraying.

DIRECTIONS

INDOORS - Within residential buildings including homes and apartments and within non-food areas of industrial, institutional and commercial buildings including hospitals, stores, manufacturing plants and warehouses for Spot Treatment only. • For Control of: Cockroaches, (including Asian and strains resistant to certain other insecticides), Ants, Spiders (including Black Widow Spiders), Crickets, Firebrats, Silverfish and stored product insect (including adults and larvae) such as Confused Flour Beetles, Sawtoothed Grain Beetles, Indian Meal Moths, Rice Weevils, Mediterranean Flour Moths and Red Flour Moths. Direct spray into cracks and crevices in walls, dark corners of rooms, cabinets and closets, along and behind baseboards, beneath and behind sinks, stoves, refrigerators and cabinets, around plumbing and other utility installations, around waste containers, and wherever else these pests may find entrance. Note: A period of four to seven days is normally required for maximum effect on cockroaches. Residual activity lasts from four to six weeks.

For Control of: Carpet Beetles - Spot Treatment - Spray along baseboard and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelves and wherever else these insects are seen or suspected.

For Control of: Fleas and Brown Dog Ticks - Spot Treatment - Spray infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and to localized areas of floor coverings where these insects may be present. Old bedding of pets should be removed and cleaned or replaced with clean, fresh bedding after treatment of pet area. Do not treat pets with this product. To control the source of fleas infestation, pets inhabiting the treated premises should be treated with a product registered for animal application.

OUTDOORS - (for use as a aid in reducing annoyance from these insects). Flies, Mosquitoes: Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also spray surfaces around light fixtures on porches, in garages and other places where these insects alight or congregate. Repeat as necessary. Ants, Brown Dog Ticks, Crickets, Fleas and Earwigs: Treat localized areas of infestation of these insects in outdoor areas where there are weeds or brushy non-crop areas. Spray infested areas thoroughly. For Ants thoroughly wet hills and runways. Repeat applications as infestations warrant and as reinfestations occur.
