

PRECAUTIONARY STATEMENTS

CAUTION

Hazards to Humans and Domestic Animals

Harmful if swallowed or absorbed through skin. Avoid breathing vapor and spray mist. Avoid contact with skin and eyes. Remove pets, birds and cover fish aquariums before spraying. Do not apply directly to or around food. Cover or remove any food utensils and food processing equipment during application. Do not apply while food processing is underway. After space spraying in areas where food is handled, wash all equipment, benches, shelving, etc. where exposed food will be handled with potable water.

Statement of Practical Treatment

If Swallowed: Call a physician or Poison Control Center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear. Never induce vomiting or give anything by mouth to an unconscious person. If on Skin: Wash contaminated clothing and wash affected areas with plenty of soap and water. If in Eyes: Flush eyes with plenty of water. Call a physician if irritation persists. If Inhaled: Remove victim to fresh air. Apply artificial respiration if indicated.

Environmental Hazards

This pesticide is highly toxic to fish, birds and other wildlife. Do not apply directly to water or wetlands (swamps, bogs, marshes and potholes). Drift and runoff from treated sites may be hazardous to fish in adjacent waters.

Physical and Chemical Hazards

Contents under pressure. Do not use near heat or open flame. Do not puncture or incinerate. Exposure to temperatures above 130°F may cause bursting.

Storage and Disposal

Storage: Store in a cool place away from heat, direct sunlight, or open flame. Keep in original container and preferably in a locked storage area. Disposal: Replace cap and discard container in trash. Do not puncture or incinerate.

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SHAKE CAN WELL BEFORE USING. Aim spray opening away from person. Push button to spray.

TO KILL FLEAS & TICKS ON DOGS AND CATS: Apply directly to animals along back, under forelegs, and other areas except scrotum and anus. Part hair to contact skin and insure good coverage. Hold nozzle about one foot away while spraying. Apply until hair is thoroughly moist. Do not spray directly in eyes or mouth of animal. Repeat within 24 hours of first treatment, if necessary. Note: This aerosol may make a slight hissing sound and cause a temporary cool sensation. Hold pet securely while applying. Nervous animals may become frightened the first time this product is used but soon become accustomed to the treatment.

TO KILL FLEAS & TICKS IN PET BEDDING AND PET AREAS: To reduce reinfestation, thoroughly spray the animal's bedding and other resting places until surface is slightly moist. Treat these areas at the rate of two seconds per linear foot at a distance of 12 to 18 inches. Also spray entire inside surface of dog houses. Repeat as necessary.

TO TREAT FLEA & TICK INFESTATION IN RUGS AND CARPETS: Spray rugs and carpets where fleas tend to hide. If used on light or delicate upholstery fabrics, test for potential staining in an inconspicuous place prior to use. Spray thoroughly into hiding places such as cracks and crevices, in walls and floors, along baseboards, windows and door frames. Repeat as necessary.

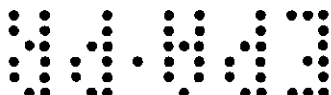
