**PRECAUTIONARY STATEMENTS**

**CAUTION**

**Hazards to Humans and Domestic Animals**

Harmful if swallowed or absorbed through skin. Avoid breathing vapor and spray mist. Avoid contact with skin and eyes. Remove pets, birds and cover fish aquariums before spraying. Do not apply directly to or around food. Cover or remove any food utensils and food processing equipment during application. Do not apply while food processing is underway. After space spraying in areas where food is handled, wash all equipment, benches, shelving, etc. where exposed food will be handled with potable water.

**Statement of Practical Treatment**

**If Swallowed:** Call a physician or Poison Control Center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear. Never induce vomiting or give anything by mouth to an unconscious person. **If on Skin:** Wash contaminated clothing and wash affected areas with plenty of soap and water. **If In Eyes:** Flush eyes with plenty of water. Call a physician if irritation persists. **If Inhaled:** Remove victim to fresh air. Apply artificial respiration if indicated.

**Environmental Hazards**

This pesticide is highly toxic to fish, birds and other wildlife. Do not apply directly to water or wetlands (swamps, bogs, marshes and potholes). Drift and runoff from treated sites may be hazardous to fish in adjacent waters.

**Directions for Use**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This product will kill Houseflies, Mosquitoes, Centipedes, Fleas, Wasps, Saw-toothed Grain Beetles, Ticks, Black Carpet Beetles, Rice Weevils, Small Flying Moths, Spiders, Pill Bugs, Crickets and Silverfish. Aids in the control of Cockroaches and Waterbugs.

Cover exposed food, dishes and food-handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Put out all flames. Close doors and windows. Point valve opening away from face and eyes when releasing. Use one unit for each 6,000 cubic feet of unobstructed area. Do not remain in the area during treatment and ventilate thoroughly before re-entry.

**TO OPERATE VALVE:** To lock valve in open position for automatic discharge, press valve button all the way down, hooking the catch. Then place fogger on stand or table in the center of the room with valve locked open, placing several layers of newspaper or pad under fogger. Leave building at once and keep building closed for two hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary.

**To Kill Ticks:** Destroy old pet bedding and replace. Use product as above. Treat dogs and cats with registered tick control product prior to re-entry.

**To Kill Fleas:** Follow directions for ticks.

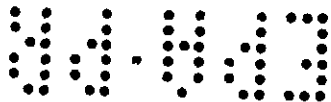
