CAUTION

Hazards to Humans and Domestic Animals

Harmful if swallowed or absorbed through skin. Avoid breathing vapor and spray mist. Avoid contact with skin and eyes. Remove pets, birds and cover fish aquariums before spraying. Statement of Practical Treatment

If Swallowed: Call a physician or Poison Control Center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear. Never induce vomiting or give anything by mouth to an unconscious person. **If on Skin:** Wash contaminated clothing and wash affected areas with plenty of soap and water. **If In Eyes:** Flush eyes with plenty of water. Call a physician if irritation persists. **If Inhaled:** Remove victim to fresh air. Apply artificial respiration if indicated.

Environmental Hazards

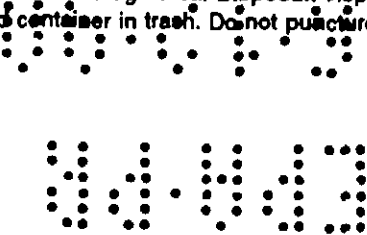

To kill Flies, Mosquitoes, Gnats, Wasps and Flying Moths: Close all windows and doors and direct spray upward into center of room with a slow, sweeping motion. Thoroughly mist the room with spray. Keep nozzle three feet from surfaces. May stain finished surfaces if sprayed too closely. Keep room closed for 15 minutes after spraying.

To kill Roaches, Waterbugs, Silverfish, Crickets and Ants: Spray baseboards, cracks, crevices, moist areas, and openings around sinks and pipes and other hiding places, hitting the insects directly. Spray ant hills and ant trails, over window and door sills and other locations. Repeat as necessary for control.
