Your submission dated April 10, 2002

The amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(7)(a), is acceptable provided that you:

1. Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.
2. Submit three (3) copies of your final printed labeling before you release

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

We note that the minor formulation change submitted in February was found unacceptable. See the July 5, 2002 letter from the Minor Formulation Review team.

Chemsico Roach Control System I works by attracting roaches to the bait tray. They eat the bait and crawl away to die.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. *For household use only.*

OPTION 1

1. Break bait apart from plastic frame before using.
2. Place bait where you have seen roaches or in out-of-the-way places near walls, in cabinets, under sinks and refrigerators and in closets. Use at least 10 bait stations in the kitchen and 2 in each bathroom. Heavily infested areas may require additional baits. [To apply to vertical surfaces, use the stick-up tape provided.]
3. For continued control replace baits every 4 months, sooner if infestation is heavy.

OPTION 2

1. Open pouch and break bait stations apart from each other.
2. Place bait stations where roaches have been seen or in out-of-the way places near walls, in cabinets, under sinks and refrigerators and in closets. Recommended locations: Use at least 10 bait stations in the kitchen and at least 2 in each bathroom. Heavily infested areas may require additional bait stations. [To apply to vertical surfaces, use the stick-up tape provided.]
3. Replace baits every 4 months for continued control or sooner if infestation is heavy.

STORAGE AND DISPOSAL

Storage: Store in an area inaccessible to children. **Disposal:** If empty: Do not reuse this container. Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions.
