The revised labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. A stamped copy is enclosed for your files.

1. At the present time, we are willing to accept the use of the phrase, "Time Release Capsules" on your product labeling. However, subject to review in the future, we may ask you to remove this phrase.
2. In the Environmental Hazards section, you may delete the sentence which is stated as "Drift and...adjacent waters."
3. The deletion of the phrase, "Do not contaminate ... equipment washwaters" is acceptable as long as this product remains a ready to use aerosol product.
4. In the "Note to Physician" statement, please add the word "used" between the words, "be" and "as."

The comments listed above must be incorporated on the label before it is released for shipment.

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

CAUTION: Harmful if swallowed or absorbed through skin. Do not get in eyes, on skin or clothing. Avoid breathing spray mist. Wash thoroughly with soap and water after handling and before eating or smoking. Remove contaminated clothing and wash before reuse. Keep away from food, feedstuffs, and water supplies. Do not use this product in food areas of food handling establishments or other areas where food is prepared or processed.

Statement of Practical Treatment

If Swallowed: Call a physician or Poison Control Center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not give anything by mouth to an unconscious person. **If in Eyes:** Flush eyes with plenty of water. Get medical attention if irritation persists. **If on Skin:** Wash affected areas with soap and water. Get medical attention if irritation persists. **If Inhaled:** Remove to fresh air. Apply artificial respiration if indicated and get medical attention immediately. **NOTE TO PHYSICIAN:** This product may cause cholinesterase inhibition. Atropine is antidotal. 2-PAM may be as an adjunct to atropine.

Environmental Hazards

This pesticide is highly toxic to fish, birds and other wildlife. Do not apply directly to water. Drift and runoff from treated sites may be hazardous to fish and to aquatic organisms in adjacent waters.

Physical or Chemical Hazards

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting.

GENERAL INFORMATION: Chemsico Ant & Roach Killer is a micro-encapsulated product designed for use as a spray to control various pests in and around households and non-food areas of industrial, institutional or commercial buildings. Chemsico Ant & Roach Killer may be sprayed on any surface which will not be damaged or stained by water. A visible deposit may appear on some dark surfaces. This deposit can be easily removed with a cloth, with a damp sponge or with a vacuum cleaner. **NOTICE:** Read and understand the entire label before using. Use only according to label directions.

Directions for Use

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do not apply this product to conduits, motor housings, junction and switch boxes, or other electrical equipment because of possible shock hazard. **Attention:** Remove pets and cover fish bowls (tanks) before spraying. Do not allow adults, children or pets on treated areas until spray has dried. Keep out of fish pools or other bodies of water. Do not treat vegetable gardens. Do not use in poultry houses.

Indoors: Use Chemsico Ant & Roach Killer to control infestations of listed pests. Applications may be made within homes and apartments, and non-food areas of industrial, institutional or commercial buildings. Do not allow spray to contact food or food-contacting surfaces, feedstuffs or water
