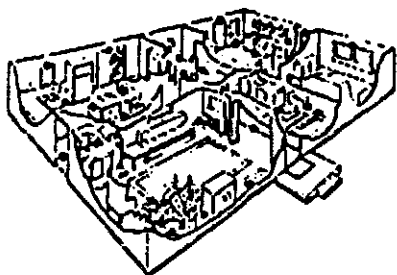

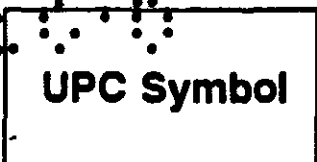

Spray areas where cockroaches, ants, clover mites, crickets, firebrats, silverfish and spiders are found or normally occur including dark corners of rooms and closets, cracks and crevices in walls; along and behind baseboards; beneath and behind sinks, stoves, refrigerators and cabinets; around plumbing and other utility installations. For ants, apply to ant trails; around doors and windows and wherever else these pests may find entrance. For control of carpet beetles, thoroughly spray along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever else these insects are seen or suspected. For control of fleas and brown dog ticks, thoroughly spray pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean fresh bedding after treatment of pet area. Do not treat pets with this product. To control the source of flea infestations, pets infested by the treated pest should be treated with a product registered for application to animals. Note: Check carpet manufacturer's warranty and care and maintenance information before using product on your specific brand of carpeting.
