

Under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, this pesticide is registered under EPA Reg. No. 9688-86

Use on roaches, in garages and other places where insects alight or congregate. Repeat as necessary. Ants, Brown Dog Ticks, Crickets, Fleas and Earwigs - Treat localized areas of infestation of these insects in outdoor areas where there are weeds or bushy non-crop areas. Spray infested areas thoroughly. For Ants thoroughly wet hills and runways. Repeat applications as infestations warrant and as reinfestations occur.

**STORAGE AND DISPOSAL**

Store in cool, dry area away from heat or open flame. Discard container in trash. Do not incinerate or puncture container.

In addition to rapid initial kill, Chemisco Tralomethrin Insecticide B stays on treated surfaces and provides residual insect killing power for up to two months after spray deposit has dried.

**Directions for Use**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Read entire label. Use strictly in accordance with label precautionary statements and directions.

**Shake Well Before Using**

**HOW TO USE:** Spray infested surfaces until wet moving the spray stream rapidly to prevent excessive wetting of surfaces and waste of material. Point spray away from people, plants and pets. Do not introduce the spray into air or allow the spray to contact food or food contacting surfaces. Thoroughly wash dishes and food handling utensils with soap and water if they become contaminated by application of this product. Do not allow children or pets to contact treated surfaces until spray has dried. Remove pets and cover fish bowls (tanks) before spraying.

**DIRECTIONS: INDOORS for SPOT TREATMENT only -** Within residential buildings including homes and apartments and within non-food areas of industrial, institutional and commercial buildings including stores, manufacturing plants, warehouses and hospitals (NOTE: Do not apply this product in hospital patient rooms while occupied or in any room while occupied by the elderly or infirm). For control of Cockroaches, Ants, Spiders (including Black Widow Spiders), Crickets, Firebrats, Silverfish and stored product insects (including adults and larvae) such as Confused Flour Beetles, Saw-toothed Grain Beetles, Indian Meal Moths, Rice Weevils, Mediterranean Flour Moths and Red Flour Moths. Direct spray into cracks and crevices in walls, dark corners of rooms, cabinets and closets, along and behind baseboards, beneath and behind sinks, stoves, refrigerators and cabinets, around plumbing and other utility installations, around waste containers and wherever else these pests may find entrance. Residual activity lasts up to two months. For control of Carpet Beetles, spray along baseboard and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelves and wherever else these insects are seen or suspected. For control of Fleas and Brown Dog Ticks, spray infested areas such as pet beds and resting quarters, hearty cracks and crevices, along and behind baseboards, window and door frames and to localized areas of floor coverings where these pests may be present. Test inconspicuous sample of fabric or rug for staining before use. Old bedding of pets should be removed and cleaned or replaced with clean, fresh bedding after treatment of pet area. Do not treat pets with this product. To control the source of fleas infestation, pets inhabiting the treated premises should be treated with a product registered for animal application.

**OUTDOORS -** (for use as an aid in reducing annoyance from these insects): Flies, Mosquitoes - Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also spray
