Directions for Use: It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Mixing Directions:

Note: This is a single use container, and the entire contents of the bottle are to be used at one time. This concentrate refill will make one gallon of Chemsico Home Insect Control A. It is intended to be used in an empty Chemsico Home Insect Control A one gallon container only, and is not to be put into any other containers or bottles.

Pour the entire contents of this bottle into an empty one gallon Chemsico Home Insect Control A container. Then fill this bottle with water and pour the contents into the gallon container. Repeat at least two additional times to completely rinse out the contents. Add water to the gallon container to fill approximately one inch from the top. Replace the cap and shake contents well before use.

Sprayer Instructions:

How to prime and care for your sprayer:

1. After shaking product well, remove cap from container and replace with sprayer hose and cap assembly. Tighten securely.
2. Turn sprayer nozzle one half turn counter-clockwise. Hold sprayer below the level of container and prime by pumping trigger 10-15 times until product is dispensed. Adjust nozzle to fine spray or jet stream as needed.
3. To store, turn nozzle to "OFF" position and store with sprayer above level of liquid in container to prevent leakage.

FOR HOMES, APARTMENTS AND BUILDINGS

INDOORS: Spray areas where cockroaches, Palmetto bugs, ants, clover mites, crickets, firebrats, silverfish and spiders are found or normally occur including dark corners of rooms and closets, cracks and crevices in walls; along and behind baseboards; beneath and behind sinks, stoves, refrigerators and cabinets; around plumbing and other utility installations. For ants, apply to ant trails; around doors and windows and wherever else these pests may find entrance. For control of carpet beetles, thoroughly spray along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever else these insects are seen or suspected. For control of fleas and brown dog ticks, thoroughly spray pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor, and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean fresh bedding after treatment of pet area. Do not

For ants, thoroughly wet hills and runways. Repeat as needed.

STORAGE AND DISPOSAL: Store in cool, dry area away from heat or open flame. Discard container in trash.
