Dear Ms. Tryson:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable, subject to the comments listed below.

1. Please delete the statement "No unpleasant odor" from the claims made on the label. This is a subjective statement based upon the sensitivity of the user.
2. Under the PRECAUTIONARY STATEMENTS section, move the statements "Avoid contamination of food, feedstuffs...aquariums before spraying." to the "Directions for Use" section.
3. Under INDOORS, add the following sentence to the end of the paragraph "Also, treat your yard with a product registered for yard application."
4. Under OUTDOORS, either delete the phrase "Repeat as needed" or indicate a time period based on the residual efficacy of your product.
5. Revise the first sentence after OUTDOORS to read: "For outdoor use only as an aid in controlling these insects"
6. Move the STORAGE AND DISPOSAL section to the end of the label

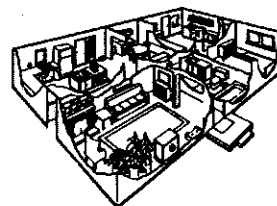
Sprayer Instructions (optional):

How to prime and care for your sprayer:

1. After shaking product well, remove cap from container and replace with sprayer hose and cap assembly. Tighten securely.
2. Turn sprayer nozzle one half turn counter-clockwise. Hold sprayer below the level of container and prime by pumping trigger 10-15 times until product is dispensed. Adjust nozzle to fine spray or jet stream as needed.
3. To store, turn nozzle to "OFF" position and store with sprayer above level of liquid in container to prevent leakage.

INDOORS:

FOR HOUSEHOLD USE — INDOORS: Spray areas where **cockroaches, Palmetto bugs, ants, clover mites, crickets, firebrats, waterbugs, silver-fish and spiders** are found or normally occur including dark corners of rooms and closets, cracks and crevices in walls; along and behind baseboards; beneath and behind sinks, stoves, refrigerators and cabinets; around plumbing and other utility installations. **For ants**, apply to ant trails; around doors and windows and wherever else these pests may find entrance. **For control of carpet beetles**, thoroughly spray along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever else these insects are seen or suspected. **For control of fleas and brown dog ticks**, thoroughly spray pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean fresh bedding after treatment of pet area. **Do not treat pets with this product.** To control the source of flea infestations, pets inhabiting the treated premises should be treated with a product registered for application to animals. *Note: Check car-pet manufacturer's warranty and care and maintenance information before using product on your specific brand of carpeting.*

OUTDOORS: Files, mosquitoes: For use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also spray surfaces around light fixtures, on porches, in garages and other places where these insects [alight] [land] or congregate. Repeat as needed. **Ants, brown dog ticks, crickets, fleas and earwigs:** For treatment of localized infestation of these insects where there are weeds or bushy non-crop areas, spray infested areas thoroughly. For ants, thoroughly wet hills and runways. Repeat as needed.

STORAGE AND DISPOSAL

Storage: Store in cool, dry area away from heat or open flame.

Disposal: If empty: Do not reuse this container. Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.
