## DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. For household use.

SHAKE WELL BEFORE EACH USE.

TO KILL FLYING INSECTS: Houseflies, Blackflies, Mosquitoes, Cluster flies, Gnats, Midges, Fruit flies and Flying moths (Millers): Adjust nozzle to deliver a fine spray. Close all doors and windows. Cover or remove fish bowls and remove pets. Keep spray away from fabrics and other surfaces that can be harmed or stained by water. Point sprayer upward, fill room with mist. Leave room immediately after spraying. Keep room closed for at least 15 minutes. To treat porches and patios, spray with a slow sweeping motion covering area with a fine mist. Spray only when the air is calm. Allow the spray to dry before occupying the treated area.

TO KILL CRAWLING INSECTS: Ants, Cockroaches, Waterbugs, Palmetto bugs, Crickets, Silverfish, Firebrats, Earwigs, Spiders, Sowbugs, Pillbugs and 0 Centipedes: Adjust nozzle to deliver a coarse spray. Keep spray away from fabrics and other surfaces that can be harmed or stained by water. Spray thoroughly into hiding places, such as cracks, moist areas, openings around pipes and sinks, under S 600 refrigerators, baseboards, storage areas and other insect harborage areas. Soray directly on insects where possible. To kill Spiders: Spray directly on these pests and use repeated applications to the webbing and all cracks and crevices which harbor spiders. To kill Ants (including Fire ants): Spray doors, around window frames, and other points of entry. Spray ant trails, nests, and hills contacting as many ants directly as possible. To kill Carpet beetles, thoroughly spray along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever else these insects are seen or suspected. Note: Check carpet manufacturer's warranty and care and maintenance information before using product on your specific brand of carpeting.
