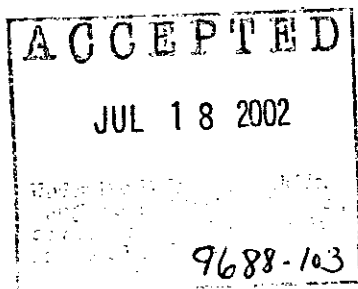

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not use in food serving areas while food is exposed. Keep people and pets off treated carpet and upholstered furniture during treatment and until area is vacuumed.

SHAKE WELL BEFORE USING. Apply to dry surfaces only. Punch plastic seal to open.

FOR CARPETS:

Sprinkle powder evenly across surface. Brush lightly with a broom to allow powder to penetrate carpet fibers. Do not allow powder to become wet. Wait 60 minutes, then vacuum. Clean carpets *AFTER* using this product.

For severe problems or where ticks are known to be hiding, wait 2 - 3 hours before vacuuming. If powder adheres to a spot, brush it out and vacuum immediately.

FOR UPHOLSTERY:

Remove all loose cushions. Sprinkle along creases and in corners. Brush gently, wait 60 minutes, vacuum. Sprinkle along underside of furniture.

NOTES:

1. Remove bag from vacuum cleaner. Wrap securely in several layers of newspaper and discard in trash.
2. Test on hidden surface of carpet or upholstery before applying. If texture or color is affected, do not use.

STORAGE AND DISPOSAL

Storage: Store in a cool dry place out of reach of children. **Disposal: If empty:** Do not reuse this container. Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.

First Aid

If Swallowed: Call a Poison Control Center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a Poison Control Center or doctor. Do not give anything by mouth to an unconscious person. **If in Eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses if present, after the first 5 minutes, then continue rinsing eye. Call a Poison Control Center or doctor for treatment advice. **If on Skin or Clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a Poison Control Center or doctor for treatment advice. **If Inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a Poison Control Center or doctor for treatment advice.
