Mix concentrate with water to the desired dilution rate.

- 4) Thoroughly wet the weeds or grass you want to kill.
- 5) Wilting and browning will begin within hours.

USE TIPS

1. For best results, apply on a sunny day when it's above 60°F. If it rains within 12 hours of spraying, retreatment may be necessary.
2. Don't spray on desirable plants - this product will kill them too. Also, don't spray on windy days to avoid drift to desirable plants. Rinse them off immediately if contact occurs.
3. Treated areas may be replanted in 48 hours.
4. Use higher concentrations (up to 12 ounces per gallon) for tough grasses such as Bermuda and Annual Bluegrass. Some hard-to-kill weeds may require more than one application.

USER SAFETY RECOMMENDATION

Clothing exposed to this product should be washed in detergent and hot water. Such items should be kept and washed separately from other laundry.
