The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable, subject to the comments listed below.

1. Under the PRECAUTIONARY STATEMENTS section, move the statements "Cover or remove...edible crops." to the "Directions for Use" section.
2. Under the FLYING INSECTS section, either delete the phrase "Repeat as necessary" or indicate a time period based on the residual efficacy of your product.
3. Add the following sentence to the Directions for Use section: "For outdoor use only as an aid in controlling these insects"

### FLYING INSECTS

Flies, Gnats, Hornets, Mosquitoes, Small Flying Moths and Yellow Jackets. Allow fog to drift over area. Direct spray toward bushes or grass from at least 4 to 6 feet away. Give special attention to breeding areas such as garbage cans and compost piles. Repeat as necessary.

### CRAWLING INSECTS

Ants, Centipedes, Cockroaches (including Asian Cock-roaches), Crickets, and Silverfish. Spray infested surface of patio or picnic area hitting as many insects as possible. Also spray legs of tables and chairs to repel ants. Spray ant hills for best control. Keep 4 to 6 feet away from ornamental plants while spraying.

### STORAGE AND DISPOSAL

**Storage:** Store in a cool, dry area inaccessible to children. **Disposal:** Do Not Puncture or Incinerate! **If empty:** Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions.

### PRECAUTIONARY STATEMENTS

#### Hazards to Humans and Domestic Animals

**First Aid**
