Cover and avoid spraying fish aquariums. Cover or remove exposed food, dishes, utensils, food handling equipment, tables, countertops or any other area where food is stored or prepared. If contact occurs, thoroughly wash with soap and water before use".

  - d. Delete the statement, "Allow surface to remain wet for at least 5 minutes" since this statement is associated with a disinfectant claim on non-porous surfaces.
  - e. On the front panel, bacteria must be qualified with the term "odor causing".
3. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

#### [HOW TO USE]

##### *Shake Well Before Use*

**Do not broadcast spray. Apply to non-food contact surfaces only.**

To kill Roaches and odor-causing bacteria they carry: Direct spray into cracks and crevices in walls, dark corners of rooms, cabinets and closets, along and behind baseboards, beneath and behind sinks, stoves, refrigerators and cabinets, around plumbing and other utility installations, around waste containers and wherever else these pests may be found. Spray until wet. Avoid excessive wetting of asphalt, tile, rubber and plastic materials. Allow surface to remain wet for at least 5 minutes.

#### STORAGE AND DISPOSAL

Store in cool, dry area away from heat or open flame. Discard container in trash. Do not incinerate or puncture container.

##### Hazards to Humans and Domestic Animals
