#### **OPTION 1 - PARAGRAPH FORM**

SHAKE WELL BEFORE EACH USE. Aim spray away from person. Push button to spray. If it's windy, stand with the wind at your back to avoid spray drift.

#### WASPS, HORNETS AND YELLOW JACKETS:

Application should be made in late evening when insects are least active. Spray liberally, soaking the nest. Chemsico's powerful spray will also kill insects that return to the nest over the next few days. Walt at least 24 hours before removing the nest.

"This product is non-staining to most home siding depending on age and cleanliness. Before using in areas where the spray may contact home siding, test in an inconspicuous area and recheck in a few hours.

#### **OPTION 2 - SIMPLIFIED DIRECTIONS**

- Apply at sunrise or sunset when insects are least active, (graphic-sunset)
- Stand a safe distance from the nest. Don't stand directly underneath.
- 3. Shake can woll before each use. Alm spray away from person. Push button to spray. (graphic-hand w/can) NOTE: "This product is non-staining to most home siding depending on age and cleanliness. Before using in areas where spray may contact home skiling, test in an inconspicuous area and recheck in a few hours.
- Spray the nest until soaked. (graphic-nest) Chemsico's powerful spray will also kill insects that return to the nest over the next few days.
- 5. Wait at least 24 hours before removing the nest.

#### **USE TIP**

If it's windy, stand with the wind at your back to avoid spray drift.

#### OTHER PESTS (For both formats)

Tent Caterpillars: Apply in the late afternoon or evening when caterpillars have returned to their tents. Soak tents on all sides. Scorpions: Stand at a safe distance and use the power of the jet spray to reach and cover the target. Ants: Spray trails, nest and point of entry. Spray on ants where possible. Repeat as necessary. Spiders: Direct short burst of spray on spider and repeat as necessary

#### STORAGE AND DISPOSAL

Store in cool, dry area away from heat or open flame. Discard container in trash. Do not incinerate or puncture.
