You must delete the instruction to "Repeat as necessary" in the directions for use to control "Ants" and "Spiders" under "Other Pests"; alternatively, you may revise this statement in each case to specify a re-treatment interval that is consistent with supporting product performance data for this product.
2. Correct the minor typographical error in the Physical Hazards section: "130□F" should be "130°F".

OPTION 1 - PARAGRAPH FORM

2. Stand a safe distance from the nest. Don't stand directly underneath.
3. Shake can well before each use. Aim spray away from person. Push button to spray. (graphic-hand w/can)

4. Spray the nest until soaked. (graphic-nest) Chemsico's powerful spray will also kill insects that return to the nest over the next few days.
5. Wait at least 24 hours before removing the nest.

Tent Caterpillars: Apply in the late afternoon or evening when caterpillars have returned to their tents. Spray on ants where possible. Repeat as necessary. **Spiders:** Direct short burst of spray on spider and repeat as necessary
