Delete "Kills grubs in hours!"

- c. On the first page of the draft labeling, delete the paragraph immediately beneath the net weight statement. You may substitute "Chemsico Granules Formula B kills grubs that damage your lawn." (The claims "kills grubs in hours" and "one application lasts all season long" are not supported by data.)
- 3. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

HOW TO USE

Apply to the lawn once anytime spring through summer. Control of grubs is best when they are still small; therefore, late summer treatments are preferable to spring.

Apply uniformly to assure coverage, then water in thoroughly with ½ to ¾ inch of water.

Chinch bugs, Leafhoppers, Sod webworms, Ants, Brown dog Ticks, Centipedes, Crickets, Earwigs, Firebrats, Fleas, Ground Beetles, Millipedes, Pillbugs, Scorpions, Silverfish, Sowbugs, Spiders

1.5-3 lbs. per 1,000 sq. ft.

Apply when pests are evident. Use adequate quantity of water to thoroughly moisten grass and thatch.

IF ON SKIN: Remove contaminated clothing. Wash with plenty of soap and water. Launder clothing separately before reusing. Get medical attention if irritation persists. IF IN EYES: Flush eyes with plenty of water. Call a physician if irritation persists. NOTE TO PHYSICIAN: Bendiocarb is a moderate, reversible cholinesterase inhibitor. Intravenous injection of atropine is antidotal.
