1. Place several layers of newspaper or paper towels on a table, stand or floor in center of room. Cover waxed wood floors and waxed furniture in the immediate area surrounding the fogger. Newspapers may be used.

3. Set can on newspaper or paper towels and leave the premises immediately. Do not reenter treated area for two hours.

### AIRING OUT

After two hours, open all doors and windows, turn on air conditioner and fans and air out for 30 minutes. Re-apply every four weeks if needed.
