Dear Ms. Miller:

Enclosed please find our Notification to correct two errors on the current label for the subject product. In the Agency's acceptance letter dated May 30, 2002 (copy enclosed for your reference), we were instructed to "revise 4 to read as 12" in the Use Tips, and to add "Handlers must wear long-sleeved shirt and long pants, sock(sic), and shoes". When we submitted Final Printed Labeling, we inadvertently corrected only one of the two sets of Use Tips, and neglected to add "long sleeved shirt". We didn't realize our error until it was recently brought to our attention by the state of Texas. We are also taking this opportunity to delete 1-800-CLEANUP from the Disposal section.

This notification is consistent with the provision of PR Notices 98-10 and 2007-1 and the requirements of EPA regulations at 40 CFR 156.10 and 152.46 and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if this notification is not consistent with the terms of PR Notices 98-10 and 2007-1 and 40 CFR 156.10 and 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.
