Dear Michael Sarli:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the Registration Review of the above referenced product in connection with the Diquat Dibromide and Fluazifop-p-butyl Interim Decisions, and has concluded that your submission is acceptable.

A copy of your label stamped “Accepted” is enclosed. This labeling supersedes all previously accepted labeling. Products shipped after 12 months from the date of this amendment or the next printing of the label, whichever occurs first, must bear the new revised label. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling.

Should you wish to add/retain a reference to the company’s website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product’s label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false

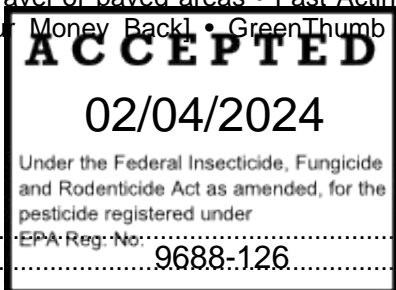

3. PRIME SPRAYER. Turn the sprayer nozzle one-half turn counter-clockwise. Hold the sprayer lower than the bottle and squeeze the trigger several times until it sprays. Adjust the nozzle to coarse spray pattern. Avoid sprays which are too fine because they can drift and damage other plants.
4. SPRAY UNWANTED GRASS & WEEDS UNTIL COMPLETELY COVERED. Wilting and browning will begin within hours.

{OPTION B: Trigger Sprayer Applicator}

1. SHAKE WELL
2. Turn the nozzle to coarse spray pattern. Avoid sprays which are too fine because they can drift and damage other plants.
3. SPRAY UNWANTED GRASS & WEEDS UNTIL COMPLETELY [COVERED][WET]. [Wilting and browning will begin within hours.]

{OPTION C: Sprinkler Cap Applicator}

1. SHAKE WELL (graphic).
2. Remove cap from sprinkler head. Make sure that the sprinkler head is screwed firmly onto bottle. The width of the pattern can be adjusted by raising or lowering the bottle.
3. INVERT BOTTLE AND WET UNWANTED GRASS & WEEDS COMPLETELY. Wilting and browning will begin within hours.

{OPTION D1 DIRECTIONS FOR CAPTIVE SPRAYER PRODUCT}**[HOW TO USE] [BEFORE USE:]**

1. Shake well before each use.
2. Peel sticker from flip-top cap and open cap. Discard sticker.
3. Remove sprayer from its slot beneath the bottle handle and remove and discard plastic wrap. Pull black hose tip to completely extend tubing.
4. Firmly press black hose tip into opening in cap until it snaps into place.

4. Firmly press black hose tip into opening in cap until it snaps into place.
5. Slide switch on hose ply counter-clockwise to "OPEN"
6. Hold sprayer below the level of the container and prime by pumping trigger several times until product is dispensed.
7. Adjust nozzle to desired setting.

AFTER USE:

1. Remove sprayer from side holder. [Unwrap the tubing] [Gently pull tubing out].
2. Remove seal from top of cap. Unplug cap.
3. Securely snap the [green] plug into hole on cap.
4. Remove plastic tab near [top] [bottom] of sprayer to activate batteries.
5. Twist nozzle to adjust spray from CLOSE to SPRAY or STREAM.
6. [When priming the sprayer, hold sprayer level to the ground. Sprayer may not prime if it is held at an angle. Once primed, it will spray in any direction.] [Keep reusable EZ Spray [sprayer] for use with Chemsico Grass & Weed Killer PP RTU

{OPTION E2 ALTERNATE OPERATING INSTRUCTIONS FOR EZ SPRAY™}**[HOW TO USE] [BEFORE USE:]**

1. Remove cap and replace with reusable [EZ Spray] [Sprayer.] Make sure sprayer cap is tightly closed before use
2. Twist nozzle to adjust spray from CLOSE to SPRAY or STREAM. [Graphic depiction]
3. [When priming the sprayer, hold sprayer level to the ground. Sprayer may not prime if it is held at an angle. Once primed, it will spray in any direction.
 - Aim toward target [site] [area to be treated], and away from people and pets.
 - Press the trigger to spray.
 - Release the trigger to stop spray.

AFTER USE: 1. Twist nozzle completely to CLOSE position. 2. Secure sprayer [upright] [tip down] in [holster] [holder]. 3. Failure to adjust nozzle completely to CLOSE position and properly secure sprayer in [holster] [holder] may result in leakage and damage to property or injury to people or animals.

2. Open flip top closure
3. Securely snap the hose plug into opening in cap until it snaps into place.
4. Slide switch on hose plug counter-clockwise to "OPEN" [Keep reusable EZ Spray [sprayer] for use with Chemsico Grass & Weed Killer PP RTU

USE TIPS

1. For best results, apply on a sunny day when it's above 60° F. If it rains within 12 hours of spraying, re-treatment may be necessary.
2. Don't spray on desirable plants - this product will kill them too. Also, don't spray on windy days to avoid drift to desirable plants. Rinse them off immediately if contact occurs. *{ALTERNATE:}* [Don't spray on windy days to avoid drift to desirable plants. If desirable plants are accidentally sprayed, rinse immediately with water.]
3. Treated areas may be replanted in 48 hours.
4. Some hard-to-kill weeds or grass such as Annual Bluegrass may require more than one application. *{ALTERNATE:}* [Some hard-to-control weeds and grasses may require more than one application.]
