Roaches, Ants, Spiders, Waterbugs, Silverfish, Crickets, Centipedes and Sowbugs: Spray into hiding places such as cracks and crevices, behind sinks, cabinets, along baseboards and floors, around drains and plumbing, hitting insects with spray whenever possible, Repeat treatment as necessary.

Exposed stages of Confused Flour Beetles, Sawtoothed Grain Beetles, Red Flour Beetles, Rice Weevils, Granary Weevils and Grain Mites: Spray into cracks and crevices. around closed cartons or containers or other areas where insects tend to hide. Spray 30 seconds for each 100 square feet [sq. ft.] of surface. Keep area closed for 45 - 60 minutes after treatment. Repeat application as necessary.

FOR FLYING INSECTS

Files, Mosquitoes, Gnats, Wasps and Flying Moths: Close all doors and windows. Direct spray to all parts of the room, especially windows and other light sources which attract insects. Keeping can in constant motion, spray room at the rate of 2 - 3 seconds por 1,000 cubic feet. Repeat treatment as necessary.

Spray 7 - 10 seconds for each 1,000 cubic feet of space.

Keep area closed for 15 minutes following treatment. Repeat applications weekly or as needed.
