On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act. Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In orde to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is unconditionally registered in accordance with FIFRA sec. 3(c)(5), provided that you:

- 1. Make the following labeling changes listed below before you release the product for shipment:
- On the side panel of your label, under the "Precautionary Statements" section, please change the second and third sentence to "Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.
- Add the following statement to the front of the label "For Residential Use Only."
- EPA has issued PR Notice 2000-3 revising first aid statements. This notice is currently pending public comments. The following are revised statements that will be required for products placed in toxicity category III and above. You may wish to incorporate these statements on your labeling at this time.

"IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice."

Revise the language in your boxed text to read: "The purpose of such applications of Chemsico Aerosol Insecticide T is to kill workers or winged reproductive forms which may be present in treated channels at the time of treatment. Such applications are not a substitute for mechanical alteration, soil treatment or foundation treatment but are merely a supplement. This product is not recommended as sole protection against termites. For active termite infestations, get a professional inspection."
- e. Please move your STORAGE AND DISPOSAL section to the end of last panel of your label.
- f. Change all references to "termites" to "For above ground termite infestations".
- g. Delete the sentence "Apply Chemsico...instructions."
- h. Under the OPTIONAL MARKETING CLAIMS, delete the first sentence: "Expanding foam reaches termites\* [insects] [pests] where they hide." There is no evidence that the expanding foam will actually reach termites where they hide. Revise the second sentence to read "Expanding foam kills termites on contact in their tunnels."
- i. Under the HOW TO USE section, delete the statement "Spray heavily into areas vulnerable to attack [damage]." This is a subjective statement since you have not quantified what the term "Spray heavily" means.
- 2. Please submit two (2) copies of your final printed label before you release the product for shipment. Please refer to the A-79 enclosure for a further description of final printed labeling. Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.
