
On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

1. Make the following label changes:

- Revise the EPA Registration Number to read, "EPA Reg. No. 9688-167".
- Under "For Control of Fleas and Brown Dog Ticks", remove each instance of [such as...].

- c. Under PRECAUTIONARY STATEMENTS, include "or using the toilet" in the sentence beginning "Wash hands thoroughly with.....".
- d. The warranty statement is unacceptable as proposed. Revise it to read, "Manufacturer makes no warranty expressed or implied regarding the performance of this product other than indicated on the label. Buyer assumes all risk of use and/or handling of this material when such use and/or handling is contrary to label instructions".
- e. The efficacy data submitted, MRIDs 45073901, 45246009, 45246010, do not support any residual claims. Remove the general claims for residual insect protection.

For German cockroaches: submit or cite two (2) studies with the species. One study should be with treated and untreated plywood and the second with treated concrete. You should include monthly results in each of the submitted studies. The label must state the cockroach pest as "German cockroach" instead of "roaches" or "cockroaches" unless you also submit or cite studies for the American cockroach.

For crickets: same as for the German cockroach.

For carpenter ants: average % mortality was below the Agency's guideline performance standard. However, a "kills carpenter ants" claim can be added to the label.

- f. Cite or submit data for "fleas" or remove them from the label. Product performance tests should be done against the cat flea. If you want to make residual claims, you must either cite or submit appropriate data.
- g. Cite or submit data for "brown dog tick" or remove them from the label. MRID 45073901 does not meet Agency guidelines for product performance data. If you want to make residual claims, you must either cite or submit appropriate data.
- h. Remove the claim "Protects your home from..." from the label.

2. Submit two copies of the revised final printed label for the record.
